- Describe and classify the different types of connectomics data that exist across species and modalities.
- Explain the components of a basic networks analysis and apply them to an arbitrary connectomics dataset using the Brain Connectivity Toolbox.
- · Describe and interpret the architectural features common to different types of brain networks.
- Implement software to visualise brain networks.
- · Review cutting-edge research leveraging connectomics data, especially applications to brain disorders, diseases, and mental illnesses.

Knowledge of/experience with networks, graphs, basic statistics, neuroscience, and/or neuroscientific data is advantageous but not required.

Participation is an ongoing assessment based on engagement with the class, and can be met via in class and online discussions. In person attendance is expected, in the event that sickness or other unavoidable life circumstances prevent attendance, the participation grade will not be affected. The student is expected to catch up the content of any missed in person classes by using instructor provided materials.
